Students are still lacking in understanding the movements and cohesiveness of dancing in groups.

In addition, researchers saw a lack of study hours to understand the Sriwijaya Gending Dance. So that at the time of evaluation, many students were not complete in presenting dance in practice. From this fact, it is necessary to take an action or experiment on a teaching and

The research that has been carried out for approximately three weeks, starting on July 26 and the last on August 9, aims to find out the learning process of Gending Sriwijaya Dance in MAN 1 Prabumulih City. In this study, it has been said to be very good, because the learning process of Gending Sriwijaya Dance art can be seen from the results of observations of teachers by carrying out teaching and learning activities in accordance with the provisions in learning.

As for what is the foothold in This research researchers looked at three stages in the learning process of Gending Sriwijaya Dance at MAN 1 Prabumulih City, namely the preparation stage, the implementation stage and the evaluation stage. For more details of the three stages, researchers will discuss them one by one to make them more understandable. The teacher's preparation in this learning is to prepare tools and materials such as tape reccorders, props, and rooms. However, the teacher still gives direction if in the learning process it is felt that something is missing. This is because teachers want the learning taught to be able to be carried out properly and in accordance with what is expected.

After the implementation of the Sriwijaya Gending Dance learning activities, students were then given an evaluation to find out the extent of the teacher's success in providing material that has been delivered to students in the learning process from Gending Sriwijaya is expected to be able to perform dance movements well. Based on the results of the Sriwijaya Gending Dance learning process activities at MAN 1 Prabumulih City which are carried out by teachers and students with reference to the activity observation sheet, it shows that the teacher's ability in the Sriwijaya Gending Dance learning process in the activity is categorized as good, namely with an average excellent score of 86 for students in the good category, namely with an average score of 80.

Meanwhile, based on the results of the evaluation assessment carried out, it is known that the learning of Gending Sriwijaya Dance with a sample of 38 students with the criteria of "Very Good" amounted to 24 students and with the criteria of "Good" amounted to 14 students. Looking at the results of the evaluation of observation data analysis, it can be interpreted that in the learning process of Gending Sriwijaya Dance art can be categorized as very good. Then the results of the interview data with both teachers and students show that the subject teacher has applied the learning model well, according to the needs of the material taught.
